Alternate Members: Every IRB member listed as a primary member or an alternate member on IRB #1 may serve as a primary or alternate member on IRBs #2-10. Each alternate IRB member who replaces a primary member at any given meeting shall have expertise, professional competence and knowledge comparable to that of the primary member whom the alternate replaces.
